

REGULATION OF THE OUTDOOR THERMAL BALNEOTHERAPY POOL

THE MEDICAL SERVICE IS ACTIVE DURING THE OPENING HOURS TO THE PUBLIC.

IT IS FORBIDDEN:

- ACCESS TO INCONTINENT PEOPLE
- DO ANY ACTIVITY THAT MAY CAUSE DISORDER TO OTHER SWIMMERS (diving, noises, etc ...)
- THE USE OF MASKS, FINS OR OTHER EQUIPMENT
- TO SMOKE. PLEASE USE THE SPECIALLY MARKED SMOKING AREA IS REQUIRED :
 - TAKE A SOAPY SHOWER BEFORE ACCESSING THE SWIMMING POOL
 - THE USE OF THE SWIMMING CAP AND ANTI-SLIP SLIPPERS
 - GETTING OUT OF THE WATER IN THE EVENT OF A TEMPORAL
 - RESPECT THE ESTIMATED TIMES FOR THE INDIVIDUAL GAMES OF WATER:
 - **OGOO SENECK HYDROMASSAGE NOT MORE THAN 3 MINUTES**
 - ALL OTHER WOTER GAMES IN THE POOL (SWIMMING AGAINST CURRENT, WATERFALLS, COLLECTIVE WHIRLPOOL, AIR WHIRLPOOL BEDS, GEYSER) NOT MORE THAN 10 MINUTES

IT IS ALLOWED:

- ACCESS TO THE SWIMMING POOL FOR CHILDREN FROM 1 TO 14 YEARS IS ALLOVED PROVIDED THEY ARE ACCOMPANIED BY A PARENT. TERME DI CASCIANA DECLINE ALL RESPONSIBILITY FOR ANY MEDICAL HEALTH PROBLEMS RELATED TO THE ACCESS OF CHILDREN UNDER 1 YEAR.

IT IS RECOMMENDED:

- BATHING IN THE POOL ONLY AFTER LIGHT MEALS
- DO NOT EXCEED 30 MINUTES CONTINUOUSLY IN THE POOL (Particular attention should be paid to children under 12 and pregnant women)
- KEEP A DECOROUS BEHAVIOR, ABSTAINING ATTITUDES THAT MAY DISTURB OTHER CUSTOMERS

N.B. THE CUSTOMER WHO PRESENTS ANY MANIFESTATION SUBJECT TO DISEASE MUST IMMEDIATELY GET OUT OF THE SWIMMING POOL AND CONTACT THE STAFF ON SERVICE.

TERME DI CASCIANA RESERVES THE RIGHT TO EXPEL VIOLATORS OF THIS REGULATION.
